CoreWeld NB Stnd is primarily used for no bake systems but can also be used with core oil, hot box, and cold box systems. Upon complete drying it forms an inorganic bond which produces little if any gas evolution on pouring. The set time can be reduced by heating the joining surfaces to 250° F.

Storage Guidelines

For optimum performance avoid temperature extremes during storage and do not allow to freeze. Recommended 3 month use-life.
